 - Documents in support/proof of experience and last salary drawn.
 - Proof that you belong to Schedule Caste [SC], Schedule Tribe [ST] and OBC Category, if claimed by you;
 - A certificate from your present employer, if employed, stating the nature of appointment, responsibilities assigned, salary drawn etc.

- The Institute reserves the right to increase or decrease number of posts.
