On behalf of Director MNNIT Allahabad, Tenders are hereby invited from interested bidders for Auction/ Demolition of old constructed W-type Staff Quarters (04 apartments in 01 block) coming on the alignment of proposed construction of Underpass connecting the Academic and Residential Campus of the Institute on "AS IS WHERE IS BASIS" Auction shall be held at 15.00 P.M. on 23.04.2019 in the office of the Executive Engineer, MNNIT Allahabad.

Inspection of the site


The interested bidders may inspect the site on all working days between 09:00 AM to 04:00 PM (except on Saturday/Sunday/ Public Holidays) from 19.04.2019 to 23.04.2019 for the assessment with prior permission of Executive Engineer.

Earnest Money Deposit


Each bidder shall bring with him/her a Demand Draft of Rs.10,000.00 drawn in favour of Director, MNNIT Allahabad payable at Allahabad and shall submit the same before the commencement of auction on 23.04.2019.

Terms & Condition:

1. Director, MNNIT Allahabad reserves the right to withdraw the auction without assigning any reason & also if the auction amount does not exceed the salvage value of **Rs. 4,92,119.00**
2. The rates quoted by the bidder should be in Indian Rupees only. Appropriate GST or any other Cess/Tax/Govt. Charges shall be collected over and above the sale price, in accordance with the provisions of the applicable Tax Acts/ and Rules in force. Any other levy or duty shall be on the accounts of the successful bidder.
3. The bidder who has quoted the highest bid shall be awarded the work if the same is acceptable to the competent authority.
4. 50% of the bid amount shall be deposited by the successful bidder within 10 days from the date of award of contract and balance amount (50%) shall be remitted not later than 21 days from the date of award of contract, failing which the successful bidder will not be allowed to lift the demolished / dismantled material of the auctioned structure.
5. The successful bidder shall have to arrange labour, transport etc. on their own for collecting & lifting of auctioned items. Carriage and all other necessary arrangements, expenses for lifting the auctioned items in favour of successful bidder shall be borne by the successful bidder.
6. Canvassing [whether] directly or indirectly, in connection with bids is strictly prohibited and the bids submitted by the persons/agencies who resort to canvassing will be rejected, and DD forfeited.
7. The DD submitted by unsuccessful bidders shall be refunded only after the completion of the auction.
8. Time of completion of work shall be 45 days which shall be adhered strictly. In case of failure in completion within stipulated time, the successful bidder shall be penalised @ Rs. 1000/- per day for 10 days beyond which no auctioned item will be allowed to be taken out beside forfeiting the amount deposited with the Institute. The timing of execution of work for the successful bidder shall be from 10:00 AM to 05:30 PM.

9. The labourers engaged should strictly follow the discipline and decorum of the Institute and the bidder shall be liable for any accidental loss or damage to the Institute property caused by them during the execution of work. The loss so caused is to be compensated by the bidder and the same has to be deposited in the Institute chest.
10. The Institute will not be held responsible for payment of any compensation to any labourer engaged by successful bidder in case of accidents / fire etc. The bidder shall pay all compensations etc., including accidental compensations due to his labourers.
11. Implements/materials required for the above work shall be arranged by the bidder. The bidder shall pay all compensations etc., including accident compensations due to his labourers. The Institute will not be responsible for any claim by the labourers engaged by the firm.
12. In the event of failure on the part of the successful bidder to fulfil his contractual obligations, the Institute reserves the right to debar such bidder from participating in any future auction conducted by the Institute in addition to forfeiture of the EMD.
13. The competent authority reserves the right to cancel/reject any or all the bids at any time without assigning any reason thereof.
14. The Department reserves the right to terminate the contract and forfeit the security deposit at any time by giving three days notice on the following ground:
 - (i) Unsatisfactory execution or performance of the successful bidder.
 - (ii) For improper behaviour of the successful bidder or breach of the terms and conditions of the contract.
 - (iii) In the event of the bidder or his agent or servant committing or attempting to commit theft, fraud, dishonesty or gross misbehaviour in connection with the subject matter of this contract or in any other connection whatsoever concerns the business of the Institute. Decision of the department to terminate the contract shall be final and binding upon the successful bidder and no claim for damages and compensation shall lie on the Institute.
15. The auction in shall be on "as is where is" basis [and no warranty or guaranty shall be implied]. The bidders in their own interest are advised to inspect the site and satisfy themselves with the condition of the W-type Staff Quarters (04 apartments in 01 block) before they come up for auction.
