- 1. The Hospital shall accept the cases referred only by the Institute Medical Officer related to the Institute employees and their dependents for treatment and pathology.
- 2. Patients referred by the Institute is to be entertained only if they produces referral slip given by the Institute Medical Officer for every visit.
- 3. Patients referred by the Institute shall not pay for any hospitalization/OPD/IPD facilities, treatment/ testing charges in cash and they will be provided with the cashless services for the same.
- 4. In case of medical emergency, the Hospital shall provide the immediate necessary medical treatment as required subject to the condition that the Hospital attendant of the patient shall obtain the due referral from the Institute Medical Officer within 72 Hrs. In any case, if the Attendant/Patient fail to produce the referral slip from the Institute is nowhere responsible for payment.
- 5. Payment shall be made by the Institute on the basis of the bills submitted on monthly basis by the above Hospitals to the Institute Health Centre subject to statutory deductions such as TDS etc. The Bed Side Treatment (BST) details shall be submitted along with the bills duly counter signed by the patient/ patient's attendant. In any case, if the Hospital fails to produce the referral slip issued by the Institute Medical Officer, Institute is nowhere liable to pay the amount.

- 6. Hospitals shall provide services for OPD/IPD treatment facilities/testing charges/ Bed Charges/Room Rent/Operation Theater Charges etc. as per existing CGHS rates. The list of rates of treatment procedures/investigations for CGHS, Allahabad is available at http://www.cghsallahabad.gov.in, In case the bills submitted by the Hospital are exceeding CGHS rates, the Institute liability shall be limited to CGHS rates only.
