Procedure for Selection of Students for Admission in Ph.D. programmes.

- 1. Admission to the Ph.D. programmes shall be based on written test and/or interviews of the eligible / shortlisted candidates by the DDSC as per Ph.D. Ordinance clause 3.4 (1).
- 2. Weightage of the written test and interview shall be 60% and 40% respectively for preparing the final merit.
- 3. As decided in the Heads & Deans meeting held on 21.06.2013, that candidates who have obtained less than 30% marks in written test will not be considered for further processing.
- 4. Candidates will be called for an Interview on the basis of rank obtained in the written test. Total number of the candidate to be called for interview, will be three times of the total number of seats in a department, as decided in the Heads and Deans meeting held on 21.06.2013, giving due weightage to the merit and the reservation under various categories.
- 5. The written examination should be of one hour with multiple choice question [objective type]. The format should be uniform across the departments.
- 6. Seat matrix should be advertised department wise after applying the reservation policy as per Government of India norms.
- Syllabus of written examination should also be made available at Institute website for the candidates.
- Now onwards the Departmental Doctoral Selection Committee [DDSC] shall be responsible for the conducting the written examination and/or interviews. DDSC will prepare the merit list category wise. The same will be sent to Director for approval through Chairman, SDPC as per clause 3.4 [2]. Final results will be declared after applying rules of the reservation policy across the Institute. Wait listed candidates should be prepared and got approved.
- 9. The schedule of the written examination and interview shall be prepared by admission cell of the office of Dean [Academic].
- The approved list of selected candidate should be displayed on Institute website and the selected candidates shall be asked to give the preference of the supervisors before the registration and for this purpose they shall be suggested to contact the faculty members after declaration of the results.

 The Head of the Departments will finalize the supervisor before first registration in consultation with convener DDPC and faculty members, observing clause no. 12.1 (9) of Ph.D. ordinance as well.
