**Sub - Quotation for Appointment of Chartered Accountant Firm**



The scope of work would be compilation, finalization of Annual Accounts, preparation of Trial Balance, Balance Sheet, Receipt and Payment Account and Income & Expenditure Account and other accounts associated work e.g. preparation of Bank Reconciliation statements, preparation of Fixed Asset Register, preparation/filing of monthly/quarterly return of Income Tax/Sales Tax/ VAT, preparation of Form-16, attending to the queries of Government Auditors on the Account prepared by the firm and any other associated services, as and when required.

Quotations are invited from CA firms fulfilling the following criteria:

1. The firm must be empanelled with C & AG of India for the year 2015-16.
2. Firm should have office located at Allahabad.
3. The firm must have at least six partners [Category-I, as per RBI norms].
4. At least 10 staff should be with the firm.
5. Average annual turnover of the firm in each year for the last three financial years (F.Y. 2012-13, F.Y. 2013-14 & F.Y. 2014-15) should be more than Rs 35.00 Lakhs and the firm should have completed at least two similar assignments pertaining to Centrally Funded Educational Institutions/Central Government PSUs / Central Government autonomous organizations during the last three years.

- [iv] Proof regarding experience of work performed pertaining to Centrally Funded Educational Institutions during the last 3 years.
- [v] Declaration regarding number of staff with the firm
