You are requested to present yourself for **Written Test (Paper-II) and Personal Interview** at **MNNIT Allahabad**.

1. [i] The test will be conducted as per schedule given below.

- [ii] **Written Test (Paper –II)** shall consist of objective type questions of general aptitude and of technical nature related to chosen subject area of the candidates. Questions shall be in English only.
- [iii] All the candidates who have appeared in **Written Test (Paper-II)** shall be required to appear before the Selection Committee for **Personal Interview** also. **Candidates shall be called for interview at a later date. Schedule of Personal Interview shall be made available only on the Institute website. Candidates are advised to visit the Institute website regularly for details.**
2. **For Written Test (Paper –II)**, you are required to bring the following documents in original for verification/submission.
- [i] One Photo Identity Card [Aadhar Card, Driving Licence etc.] bearing residential address along with self-attested photocopy of the same.
- [ii] Two recent passport size colour photographs.
- [iii] Call letter for appearing in the **Written Test/Interview** with photograph affixed.
3. No TA shall be paid for appearing in **Written Test (Paper-II)**.
4. **For Interview**, you are required to bring the following documents in original for verification/submission. (Candidate shall be called for Interview at a later date which shall be intimated through Institute website only. Please visit the Institute website regularly for details.)
- [i] All certificates and mark-sheets in original alongwith one set photocopy of the same from High School onwards.
- [ii] Documents in support/proof of experience and last salary drawn.
- [iii] OBC/SC/ST and PWD certificate as per prescribed format, if applicable.
- [iv] For those working in Government Organizations/Autonomous Bodies/Corporation/Statutory Bodies etc. **“No Objection Certificate” [NOC]**, from their present employer [or copy of the forwarding letter in case application is forwarded through proper channel] is required, failing which you will neither be allowed to appear in the interview nor be entitled for reimbursement of T.A.
5. For appearing in Interview, you shall be reimbursed train fare upto Sleeper Class/Non AC State Transport Bus, by shortest route, on submission of tickets. Reimbursement shall be made as per Institute norms. It is also advised that candidate should make their own arrangement for overnight stay as Interview may extend for next day. No D.A. or local conveyance charge shall be paid.

6. APPLICANTS MUST FULLY SATISFY THEMSELVES ABOUT THEIR ELIGIBILITY AS PRESCRIBED IN THE REFERRED ADVERTISEMENT, BEFORE APPEARING IN THE TEST. If an applicant is inadvertently allowed to appear at the Test/Interview who otherwise does not fulfil the minimum eligibility requirements, he/she cannot, at a later date, use that as a right to claim that he/she meets the eligibility requirements. The Institute reserves the right not to allow a candidate to appear in Written Test and Interview if it is found that:
- [i] Minimum eligibility requirements are not fulfilled.
 - [ii] False documentation has been done.
 - [iii] Any other similar valid reason.

You are required to report atleast **one hour** before the time of Written Test and Personal Interview.
