The Chairman, Senate extended warm welcome to the members and thanked them for taking their time out to attend the meeting.

Agenda wise proceedings are as follows:

Item No. 09.01 : To consider the mercy appeals of B.Tech. final year students who had been awarded 'X' grade in audit course Communication Skills Workshop [HS602] of their 6th semester.

Resolution :

The Senate considered mercy appeals of B.Tech. final year students who have been awarded 'X' grade in the audit course Communication Skills Workshop [HS 602] of their sixth semester. The Senate noted that the course Communication Skills Workshop is an audit course and needs to be cleared before completing the programme. The Senate also observed that the concerned students have cleared the audit course in their eighth semester [before completing the programme]. Therefore, the Senate resolved that the students be awarded new grades, awarded in their eighth semester in lieu of grade awarded in the same subject in the sixth semester.

Item No. 09.02 : To consider the recommendations of the Standing Committee held on 12.06.2012

Resolution :

The Senate considered the recommendations made by the Standing Committee in its meeting held on 12.06.2012 [Annexure – I] and resolved as follows:

[a]. The Senate considered the recommendations of the Standing Committee on the request of Mr. Mayank [Regn. No. 20084056], a student of B.Tech. final year [Computer Science and Engineering] for allowing him to appear in three subjects in the Summer Semester-2012 and resolved that as the student is in the Final year of the B.Tech. programme therefore he be allowed for the same provided he has no other subject to be cleared to pass the programme.

[d]. The Senate considered the recommendations of the Standing Committee on the request of Mr Eshant Katiyar [Regn. No. 20081020] a student of B.Tech. final year [Civil Engineering] for allowing him to appear in four subjects in the Supplementary Examination and resolved that as the student is in the Final year of the B.Tech. programme therefore he may be allowed for the same provided he has attended the courses in any of the semesters and no other subject is to be cleared by the student to pass the programme.

[e]. The Senate considered the recommendations of the Standing Committee on the request of Mr Pankaj Kumar Singh [Regn. No. 20056014] a student of B.Tech. final year [Production and Industrial Engineering] for allowing him to appear in four subjects in the Supplementary Examination and resolved that as the student is in the Final year of the B.Tech. programme therefore he may be allowed for the same provided he has attended the courses in any of the semesters and no other subject is to be cleared by the student to pass the programme.

[f]. The Senate considered the recommendations of the Standing Committee on the request of Mr Awanesh Kumar [Regn. No. 20043026] a student of B.Tech. final year [Mechanical Engineering] for allowing him to appear in four subjects in the Supplementary Examination and resolved that as the student is in the Final year of the B.Tech. programme therefore he may be allowed for the same provided he has attended the courses in any of the semesters and no other subject is to be cleared by the student to pass the programme.

[g]. The Senate considered the recommendations of the Standing Committee on the request of Mr Luikang R. [Regn. No. 20072019] a student of B.Tech. final year [Electrical Engineering] for allowing him to appear in three subjects in the Supplementary Examination and resolved that as three subjects are already allowed in the Supplementary Examination, therefore the request of the student may be accepted.

[h]. The Senate considered and accepted the recommendations of the Standing Committee on request of Mr. Santosh Kumar Rao [Regn. No. 20041041], a student of B.Tech. final year [Civil Engineering] to register in Environmental Engineering-I Course in place of Transportation Engineering -II in Summer Semester 2012.




